We did not have a raffle table in 2010. I think we should bring back the raffle table this year as well as a a special item to be raffled off for the scholarship fund. We will discuss this at the next meeting.

Our next meeting is at the Bowling Green show on February 27, 2011. I hope you brave the weather and come to the first Ohio show of 2011. Please be safe and watch those slick roads.

SWMHR Show Rules

1. This is an official ARBA sanctioned shows and will be governed by the latest show rules. Filing of an entry indicates acceptance of these rules.
2. Show Date: April 9/10th, 2011. **SHOWROOM OPENS AT 6:30 A.M. SHOW STARTS PROMPTLY AT 8:00 A.M.**
3. All rabbits **MUST BE PERMANENTLY AND LEGIBLY EAR MARKED.**
4. **NATIONAL SHOW IS PRE-ENTRY—NO DAY OF SHOW ENTRIES.**
5. **SUNDAY ALL BREED SHOW IS DAY OF SHOW ENTRY ONLY. ENTRY FEE: \$3.00**
Make checks payable to SOUTHWEST MISSOURI HARE RAISERS (SWMHR).
5. Each exhibitor must fill out their own entry forms and comment cards for the **All Breed** show. Your entry form is the OFFICIAL entry. Entry forms and comment cards must match or animal will be disqualified.
Please use a separate form for the national shows and the all breed show.
Please use a separate form for Open and Youth entries and mark Open or Youth.
COMMENT CARDS MUST BE MARKED—OPEN FOR OPEN ENTRIES AND YOUTH FOR YOUTH ENTRIES. Comment cards will not be mailed. Please pick them up at the judging tables.
6. All rabbits must be entered in the name of the bonfide owner. Youth can not show the same rabbit in both open and youth shows.
7. **YOUTH MUST PUT YOUTH RABBITS ON THE JUDGING TABLE.**
8. Southwest Missouri Hare Raisers is not responsible for any loss from fire, thefts, accidents, death of rabbit or providential destruction during the show. Unruly children will not be tolerated.
9. The club reserves the right to add or substitute other judges.
10. Any animal showing signs or symptoms of disease will be removed from the showroom promptly.
11. Show reports will be mailed to each exhibitor after the show. Please make sure name, address and e-mail address is legible and correct. Comment cards will not be mailed. Pick them up as your animals leave the judging table.
12. Vendors must have permission from the superintendent to set up sales and must pay a fee of \$25.00 or equivalent in merchandise for the raffle.
13. This is a coop cage show. If you leave your rabbits in carriers, leak proof carriers will be required.
14. **SMOKING IS PROHIBITED IN THE BUILDING BY STATE AND LOCAL LAWS.**
16. The ARBA Host club reserves the right to refuse entries from all locations within 150 miles which has had a confirmed outbreak of RCD/RHD/VHD within the past 60 days of the entry deadline.
17. Any rabbit left becomes the property of SWMHR.
